Friends of the KVR Update:

Harvey Potter presents- introduction

Holiday Happening was successful, netted \$2100 Year-end appeal has been made and is attracting new members and dollars

Informational/Discussion Items:

Buggies on Old 131 Trail: Barb Sarnowski- noticed horseshoes on the paved trail; Zahm reports having seen horse and buggy on Old 131; asked about Horse and Buggies off trail, having seen some in the Billings Creek Valley to trout fish.

Maxwell: would a sign prevent horses and buggies on the KVR in a place where they don't belong?

Lind: Would talking to the Elders be a better solution than creating a sign?

Leis: We talked to the parents of one of the underage Amish community members, and that was very effective.

Hoel: Encouraging the Amish members using the KVR, would approaching the communities be a better exercise to make them feel welcome?

Leis: In the Weister Creek Valley, Amish were consulted and asked to place hitching rails in the proper places- they still haven't been put in and have been hitching to various places in the valley area.

Hoel: Have we had repeat offenders?

Leis: We're not exactly sure, but likely the same people throughout.

Maxwell: Have Land Management create a recommendation for the KVR Board.

Update on Lisney Road Land Trade:

Leis: Cites August 18th, 2022 Meeting Minutes

Vernell Vesbach purchased the house on Lisney Road in June/July Reserve owns inside corner of property, on which a driveway was placed a long time ago.

Leis highlights the areas to be traded.

August 2022 meeting minutes include removal of willow tree, collapsing of cistern, fixing of driveway.

All has been bulldozed.

Vesbach indicated that a mistake was made.

Scott Walter was the acting ED at the time when this came through and subsequent ED didn't follow up on the motion.

No assessments have been made.

General consensus: it fell between the cracks.

Charles: What steps need to be taken to get to a decision?

Leis: Reserve can trade land, only if it is of equal or greater value.

Lind: Let's get the land trade done as soon as possible.

Charles: Get the land assessed, get the land trade done.

Vesbach: Can the project move forward to complete a campground for 10 spaces.

Leis: We can't move dirt until we have done an archeological survey.

Reserve will push through with an assessor and get it in front of the Governor right away.

DOT Request Related to 2026 work on culverts:

300' Tube runs under the existing 131. Dot plans include an apron that slows down the water flow but is placed outside of the Hwy right of way.

Leis: Now would be a good time to get down there to see if water had blown out the valley from the 2018 flood.

Leis: DOT is doing their due diligence with archeology and environmental.

Lind: Would like to see the final drawings and plans before the project moves forward- to see the impacts and potential issues. If this project is completely designed and ready to dig, then fine, but if the plan changes and we give permission NOW, we don't want to be held liable for allowing changes to take place without the final details.

Leis: I'll notify them about the Boards feelings, and we'll

Leis: Initiative secured an 8k grant, so funding isn't the issue, but more staff time to help with the project.

Schultz: Education programs coming up- numbers are too low for classes at the moment. Youth Ski Club is open for registration. 5 currently enrolled.

Summer camp registration Feb. 1st. Asked for registration software, Board asked that the website be updated instead. All websites must be approved by Exec Director.

Collaborating for Adult Summer Camp- Yocum and Schultz hosting a session on wayfinding, map reading, etc. Long weekend program. June 2024.

Hosting a "Forest Bathing" program at the KVR- doesn't feel like it should be part of the KVR Education program. Instead offered a commercial use agreement, and lease of the space.
